

PLANNING PERMIT APPLICATION FEES

PLANNING AND ENVIRONMENT (FEES) 2016 (REGULATIONS)

1 JULY 2021 TO 30 JUNE 2022

The Regulations set fees in fee units. Fee units are converted to a dollar value each financial year by the Treasurer and is published in the Government Gazette. In accordance with the *Monetary Units Act 2004*, the current value of a fee unit for the 2021/22 financial year is: \$15.03

For combined permit applications (where more than one fee applies) the amount payable will be the highest fee (which would have applied if separate applications were made) plus 50% of each of the other fees (which would have applied if separate applications were made). For example, a fee for the construction of two dwellings (cost of \$500,000) and a two-lot subdivision would be \$1570.60 + \$668.85 = \$2,239.45
